This report highlights activities undertaken by IPAR-Rwanda for the financial year 2018/2019 with a focus on four key areas: 1) Policy Analysis and Research; 2) Pubic Policy Dialogue and Debate; 3) Capacity Building; and 4) Collaborations.

HIGHLIGHTS FROM FINANCIAL YEAR 2019-2020



POLICY ANALYSIS AND RESEARCH

A. Completed Projects

Twelve Research and Policy Analysis projects were completed during the financial year July 1, 2019 and June 30, 2020. These projects were in line with IPAR-Rwanda research themes, mission and vision. Through these projects, IPAR-Rwanda informed policy making process and impacted change in a number of areas. The completed projects include:

i. Economic and Demographic Study for the Six ii. Information Flows in Decision Making: The Secondary Cities in Rwanda

IPAR-Rwanda in collaboration with Surbana Jurong Consultants completed economic and demographic studies to inform optimum and adequate urban planning in the six secondary cities in Rwanda. The project involved conducting socio-economic analysis, positioning and projections for the Master Plan of each of the secondary cities namely Musanze, Muhanga, Rubavu, Nyagatare, Rusizi and Huye. The study aimed at identifying key social and economic issues for each city, assess long term economic and demographic growth expected in each city, population growth projections over a period of 30 to 50 years and assess broad land requirements for each of the cities. The six secondary cities have been identified by the Government of Rwanda to complement the City of Kigali.

IPAR-Rwanda in collaboration with Palladium Ikiraro cy'lterambere completed a research project on "Information flow in decision making" from the citizens to the local authorities and vice versa. The research that was conducted on Girinka and Vision 2020 Umurenge Programme (VUP) as case studies, aimed at assessing channels of communication for effective citizen participation in the planning, budgeting, design, monitoring and evaluation, feed-back and reform of policy and service delivery in relation to Girinka and VUP. Results from the research identified telephone, meetings and WhatsApp as the main tools of communication between administrative officials. However, Telephone and WhatsApp were also found to be inadequate in facilitating the smooth flow of information since they require airtime and internet to receive or send messages.

iii. Social Impact of Specialist Pediatric Surgical Service in Rwanda

IPAR-Rwanda in collaboration with the University Teaching Hospital of Kigali(CHUK) with funding from the University of Aberdeen completed a study on the "The Social Impact of a Specialist Pediatric Surgical Service in Rwanda: A Qualitative Evaluation of the Effects on Child, Family and Community." The study was conducted on 20 families, each with a child with one of four moderately prevalent conditions namely (Nephroblastoma or (Wilms' tumor), Ano-rectal Malformation, Hirschsprung's Disease and Hypospadias) that need complex surgery and require the family to provide post-operative care for their child. During the study, the researchers investigated the Pathways to the child's treatment, travelling for Surgery, Caring for the Child, Impact on caretakers wellbeing, and the impact on the economic security of families. The researchers made ten policy recommendations and they can be found in a policy brief on IPAR's website http:// www.ipar-rwanda.org/.

iv. Baseline survey on Fostering a Social Practice Approach to Adult Literacies for Improving People's Quality of Life in Western Rwanda

In collaboration with the University of Aberdeen and the University of Rwanda, IPAR-Rwanda completed a baseline study on "Fostering a Social Practice Approach to Adult Literacies for Improving People's Quality of Life in Western Rwanda". The objective of the study was to understand the level and perception of adult literacy in the Western Province of Rwanda where IPAR-Rwanda, University of Aberdeen and University of Rwanda are implementing a project on "Social Practice Approach to Adult Literacies" in which adults are equipped with literacy skills. The three-year project is in its second year. A full policy brief from the baseline survey is available on IPAR-Rwanda website www.ipar-rwanda.org.

v. Understanding poverty trends and poverty dynamics in Rwanda

IPAR-Rwanda and the Chronic Poverty Advisory Network (CPAN) completed a study on poverty dynamics in

Rwanda which combines an analysis of a two wave panel data set and a set of 80 life history interviews. The study aimed to explain the slowdown in the rate of poverty reduction in Rwanda, in a context of continued growth, reduced inequality, peace and stability. vi. Strengthening the Urbanization of Secondary Cities in Rwanda

IPAR-Rwanda completed a research project on "Strengthening the Urbanization of Secondary Cities in Rwanda" which was conducted in three out of six districts designated as secondary cities. Conducted in Muhanga, Nyagatare and Rubavu Districts, the research analyzed the current socio-economic status and the preferences of a set of representative households from the different sectors in the three districts, the current characteristics and the expectations of a set of businesses, and the views of key informants, citizens and business people on the future drivers of development of the three districts. In all the three districts, 3,503 households and 606 businesses were surveyed. IPAR-Rwanda proposes 13 policy recommendations to address the identified governance related challenges and socio-economic challenges to unlock the potential of secondary cities. vii. Rwanda Open Budget Survey 2019

IPAR-Rwanda in collaboration with the International Budget Partnership (IBP) completed Rwanda Open Budget Survey 2019 which aimed at assessing availability of eight documents namely Pre-Budget Statement, Executive's Budget Proposal, Enacted Budget, Citizens Budget, In-Year Reports, Mid-Year Review, and Audit Report Year-End Report on Rwanda's national budget to the public via the website of the Ministry of Finance and Economic Planning (MINECOFIN) which is responsible for the national budget. viii.Evaluation of Inland Lakes Integrated Development Project (PAIGELAC)

IPAR-Rwanda completed the evaluation of Inland Lakes Integrated Development Project(PAIGELAC) which was commissioned by the Ministry of Finance and Economic Planning(MINECOFIN). The main objective of the evaluation was to assess the impact of the project 6 years after its completion, identify key challenges encountered and provide recommendations to the commissioning authority to address some of the challenges identified.

Implemented between 2006 and 2013, PAIGELAC was funded by a loan and support from the African Development Bank to promote fisheries in Rwanda. The project activities focused on improving the environment and favoring the sustainability of the aqua biodiversity. At that time, most fishery projects in Rwanda were mainly research-oriented, and the PAIGELAC came to support fishery-related activities. Results from evaluation of the project show significant increase in fish production from 7,711 tons in 2006 to 21,740 tons in 2013 when the project closed. Fish production has since then increased to 31,465 tons in 2018.

IPAR-Rwanda completed a baseline survey commissioned by TradeMark East Africa(TMEA) on its interventions which are aimed at improving business environment in Rwanda through extending support to the responsible institutions such as Rwanda Standards Board(RSB), Rwanda Revenue Authority and others. TradeMark East Africa is a multi-donor funded, not-for-profit organization promoting regional trade and prosperity in East Africa, including Rwanda.

x. Study on Youth Employment, Education and Skills (YEES) in Rwanda

IPAR-Rwanda completed a study on Youth Employment, Education and Skills (YEES) in Rwanda. The study was commissioned by the African Center for Economic Transformation(ACET) with the aim to obtain a clearer understanding of the youth (demographic), employment, education/skills challenges in the selected countries and to learn about each country's initiatives to boost decent work in light of the rapidly evolving nature of work; and share these experiences among countries to promote and enhance policy reforms and uptake through national and multi-country platforms for knowledge sharing. In addition, the study aimed at assessing the readiness of secondary school and TVET education curricula in preparing youth for the fourth industrial revolution (4IR) technology and ICT within the Rwandan labor market.

xi. Determinants of households' saving in Rwanda

IPAR-Rwanda completed a pilot study on the determinants of households' saving in Rwanda. The objective of the study was to identify the factors driving households' saving in Rwanda. The findings of this pilot study will help to explain households' saving behavior, something that will inform decision and policy makers on the appropriate policies to boost national savings. In Rwanda, the macroeconomic framework for the National Strategy for Transformation (NST1) identifies private saving as the important driver that will boost both private investments and Growth Domestic Product(GDP) growth to reach the desired 9.1% average growth over the NST1 period. To achieve this, Rwanda targets an increase of domestic savings from 12.1% in 2017 to 23.9% in 2024 for the country to remain on its path of economic transformation. If achieved, these targets will help reduce Rwanda's reliance on Overseas Development Assistance (ODA) which has funded 42% of public investment in 2018/19.

xii. Accessibility and Spatial Distribution of Water Supply Systems in Rural Areas in Rwanda

IPAR-Rwanda completed a pilot study on accessibility and special distribution of water supply systems in rural areas in Rwanda. The pilot study was conducted in four administrative sectors of Kamonyi District in Southern Province. The overall objective of the study was to investigate the special distribution of water supply and issues affecting its accessibility in the rural areas. The outcomes of this study will inform the policy and decision-making process in order to tackle the structural barriers faced by the rural communities in accessing clean water.

B. Ongoing Projects

IPAR-Rwanda is implementing three research projects which started in the financial year 2019-2020. The three projects include:

i. Reviewing Rural Water Tariff in Rwanda

Commissioned by Rwanda Utilities Regulatory Authority (RURA) and UNICEF Rwanda, this study aims at determining demand and the willingness of the rural communities in Rwanda to pay for safe and clean water. A pilot study was conducted in March 2020 in Gikomero and Rutunga Sectors of Gasabo District to test the research tools while data collection for entire project will start in mid-August 2020. It is expected that the results from this research will inform the design of a new rural water tariff in Rwanda.

ii. Analysis of Imihigo scores and citizens' welfare

IPAR-Rwanda is analyzing Imihigo (Local and Central Government Annual Performance Contracts) scores and citizens' welfare with the general objective of assessing how performance contacts link with citizens' welfare, and to showcase the best practices, which managed to translate higher Imihigo performance into improved citizens' welfare.

Researchers are specifically assessing the robustness of the Imihigo scoring, the impact of Imihigo performance on socio-economic characteristics of households, the impact of Imihigo performance on citizens' satisfaction and identify and describe best practices for improved Imihigo impact on citizens' welfare at the district level. The analysis will cover period 2013-2017 of Imihigo evaluation results with the possibility of including the period starting from 2010 depending on the availability of datasets.

iii. Providing Timely Evidence to Facilitate the Socio-Economic Recovery from the Covid-19 pandemic in Rwanda

Funded by Canada's International Development Research Center(IDRC), this three-year research project aims at facilitating evidence based decision making for the Government of Rwanda to provide appropriate socioeconomic responses to the Covid-19 outbreak. The project will provide up-to-date and relevant information to policy makers on the impact of Covid-19 on businesses and vulnerable households and to generate and propose policy solutions to the challenges faced by businesses and vulnerable households. The project is being implemented in collaboration with Kivu International and University of Aberdeen in the United Kingdom. IPAR-Rwanda will collect data from 10,000 households and 4,500 businesses in order to gather instantaneous and ready to use information on the socio-economic and labor market impacts of Covid-19.



PUBLIC POLICY DIALOGUE AND DEBATE

A. Events organized by IPAR-Rwanda

IPAR-Rwanda organized eight workshops during the period from July 1, 2019 to June 30, 2020. However, due to the Coronavirus outbreak, IPAR-Rwanda had to cancel its most important annual research conference which was scheduled to take place in March 24, 2020 under the theme "Urbanization, Urban planning & Urban governance: The case of Secondary Cities". The institute also canceled several other workshops which were all lined up to take place between March and June 2020 due to the Coronavirus outbreak. The following are events which IPAR-Rwanda organized before the Coronavirus outbreak in March 2020.

ii. Workshops on Information Flow in Decision Making in Districts

IPAR-Rwanda conducted workshops on "Information Flow in Decision Making" in ten Districts (two from each province and the City of Kigali) from 1-29 August 2019. The workshops were part of the research project on "Information Flow in Decision Making" which was studying the flow of information from the citizens to the local leaders and vice versa with Girinka and Vision 2020 Umurenge Program(VUP) as case studies. The workshops brought together between 60 to 75 Cell and Sector officials who were trained to use a data collection tool developed by IPAR-Rwanda to facilitate data collection using mobile phones or a web-based application.

iii. Stakeholders' Workshop on Adult Literacies in Western Rwanda

On October 25, 2019, IPAR-Rwanda organized a half-day Stakeholders' Workshop on "Fostering Social Practice Approach to Adult Literacies for Improving People's Quality of Life in Western Rwanda". The workshop was held one-year after the launch and implementation of the four-year Project titled "Fostering Social Practice Approach to Adult Literacies for Improving People's Quality of Life in Western Rwanda" which is implemented by IPAR-Rwanda in collaboration with the University of Rwanda College of Education and Aberdeen University with funding from the Scottish Government. iv. Consultative Meeting on Growth and Economic Opportunities for Women in East Africa

On November 27, 2019, IPAR-Rwanda hosted a consultative meeting on Growth and Economic Opportunities for Women (GROW 2), an upcoming project initiated by Canada's International Development Research Center(IDRC) to support women's economic

empowerment in East Africa. Rwanda is among the countries to benefit from this project. The consultative meeting which was organized on behalf of IDRC brought together participants in areas of gender and women empowerment from the Government of Rwanda, Civil Society, Private Sector and Research institutions to exchange views on how to support women's economic empowerment, partly in Rwanda and in East Africa in general.

v. Presentation of preliminary Social and Economic Findings on Six Secondary Cities to the National Technical Committee

In November 2019, IPAR-Rwanda presented preliminary findings from its social and economic surveys conducted on Rwanda's six secondary cities to the national technical committee for validation in an event held in Musanze District, Northern Province. The preliminary findings covered quality of life, economic activities, infrastructure, business competitiveness, environmental factors (green growth) and housing for each of the six secondary cities namely Rubavu, Huye, Musanze, Nyagatare, Muhanga and Rusizi. The six districts have been selected by the Government of Rwanda as poles of growth to complement the City of Kigali. The findings were vital for the design of the master plan for each of the six secondary cities by Surban and Jurong Consultants.

vi. Preparatory Workshop of Utafiti Sera Forum Phase II

IPAR-Rwanda in collaboration with the Nairobi based Partnership for Social and Governance Research(PASGR) organized a one-day preparatory workshop for the incoming second phase of the Utafiti Sera Forum in Kigali which took place on December 11, 2019 at Lemigo Hotel, Kigali.

The workshop brought together 12 participants mainly from Government Institutions in Rwanda that are directly responsible for urbanization. Represented institutions were the Ministry of Infrastructure, Rwanda Housing Authority, and the City of Kigali in addition to IPAR-Rwanda and PASGR. The theme of the workshop was "Urbanization and Socio-Economic Development in Rwanda: Opportunities and Challenges in the City of Kigali and Secondary Cities".

vii. Dissemination workshop of Research findings on "Social Impact of a Specialist Pediatric Surgical Service in Rwanda

On 29 January, 2020, IPAR-Rwanda in collaboration with the University Teaching Hospital of Kigali(CHUK) and the University of Aberdeen organized a dissemination workshop of research findings on "Social impact of a specialist pediatric surgical service in Rwanda".

Funded by the University of Aberdeen Trust Fund, the study was conducted on 20 families, each with a child with one of four moderately prevalent conditions (Nephroblastoma or (Wilms' tumor), Ano-rectal Malformation, Hirschsprung's Disease and Hypospadias) that need complex surgery and require the family to provide post-operative care for their child. During the study, the researchers investigated the Pathways to the child's treatment, travelling for Surgery, Caring for the Child, impact on caretakers wellbeing, and the impact on the economic security of families. viii.Inception workshop for the study on Youth Employment, Education and Skills (YEES) in Rwanda

On January 23, 2020, IPAR-Rwanda organized an inception workshop for the study on Youth Employment, Education and Skills (YEES) in Rwanda. The workshop was held at Lemigo Hotel. During the workshop, IPAR introduced the study, its methodology and collected feedback from the stakeholders on the methodology in order to finetune it to meet the objectives of the study. The study was commissioned by the African Center for Economic Transformation(ACET) with the aim of obtaining a clearer understanding of the youth (demographic), employment, education/skills challenges and to learn about Rwanda's initiatives to boost decent work in light of the rapidly evolving nature of work; and share these experiences to promote and enhance policy reforms and uptake through national and multi-country platforms for knowledge sharing.

iii. Peace-Building Conference in Côte d'Ivoire

IPAR-Rwanda Executive Director Ms. Eugenia Kayitesi joined several delegates in a four-day peacebuilding conference which was held from July 15-18, 2019 in in Abidjan, Côte d'Ivoire.

The 2019 Southern Voices Network for Peacebuilding (SVNP) conference was co-organized by the Wilson Center Africa Program in partnership with the Centre de Recherche et d'Action pour la Paix (CERAP) and Centre Ivoirien de Recherches Economiques et Sociales (CIRES). The SVNP is a Pan-African network consisting of 23 organizations working on various dimensions of peacebuilding in Africa. The theme of the 2019 conference was "Youth and Peacebuilding in Africa." The conference, held at CERAP, convened 22 representatives from the Southern Voices Network for Peacebuilding and over 50 members of the public, policymakers, researchers, and practitioners for dialogue on youth and peacebuilding in Africa.

iv. 23rd Annual Conference of the Intergovernmental Committee of Senior Officials and Experts for Eastern Africa

The Executive Director of IPAR-Rwanda Ms. Eugenia Kayitesi attended the 23rd Conference of the Intergovernmental Committee of Senior Officials and Experts for Eastern Africa organized by the United Nations Economic Commission for Africa(UNECA) in Asmara, Eritrea on 5-7 November 2019. The conference was held under the theme "Leveraging New Opportunities for Regional Integration in Eastern Africa" and its objective was to debate policies that can leverage new opportunities for regional integration in the Eastern Africa sub-region of the United Nations Economic Commission for Africa(UNECA).

CAPACITY BUILDING

In the financial year 2019/2020, IPAR-Rwanda continued to strengthen the capacity of its research team and extended capacity building to other beneficiaries of its programs. More efforts were directed towards building the capacity of research assistants who collect data from the field. The institute also received a great number of internees from universities and others who sought professional internship in various fields. Notable achievements in the field of capacity building include:

Twenty Candidates Awarded Diploma in Adult Literacies

On November 29, 2019, IPAR-Rwanda joined its partners —University of Rwanda and University of Aberdeen—in a graduation ceremony in which 20 candidates were awarded a Continuous Professional Development(CPD) diploma in adult literacies. The ceremony was held at the University of Rwanda College of Education in Rukara, Kayonza District in the Eastern Province. The candidates were enrolled in the program which is a component of the project on "Fostering a Social Practice Approach to Adult Literacies for Improving People's Quality of Life in Western Rwanda" jointly implemented in the Western Province by IPAR-Rwanda, University of Rwanda and University of Aberdeen with financial support from the Scottish Government.

ii. Researchers Trained in Qualitative Data Analysis Techniques

Eleven researchers at IPAR-Rwanda were trained to use Nnivo, a qualitative data analysis software. The training which was conducted by Dr. Shema Jean Bosco was held at IPAR-Rwanda offices from 25-28 November 2019. Researchers learnt and applied different qualitative data analysis techniques using Nvivo. The training was organized as part of the Institute's consistent internal capacity building in the areas that are vital to improve the skills and capacity of the staff to do research and analyze policies.

iii. Training for Private Rural Water Operators

Commissioned by Rwanda Utilities Regulatory Authority (RURA) and UNICEF Rwanda to review the rural water tariff in Rwanda, IPAR-Rwanda in collaboration with Palmer Development Group(PDG), a consulting firm based in South Africa, trained 138 people from 25 Districts to use a new rural water tariff reporting system. Those trained include private water operators, water and sanitation engineers and support engineers from Water and Sanitation Corporation(WASAC). The training was held from 13 to 30 January, 2020.

MoU with University of Rwanda Partnership to Strengthen Research


